## Honoring 15 Years of Innovation: LMM Housing & Shelter

This year, Lutheran Metropolitan Ministry's Housing & Shelter program turns 15! Between a global pandemic, our Breaking New Ground campaign, and working to bring 3D-printed housing to Cleveland, 15 has been a busy and impactful year for the team.

### More Than a Place to Stay

LMM's Men's Shelter at 2100 Lakeside is the largest homeless shelter in the state of Ohio, providing beds and serving meals for up to 365 men per night. While this service area does provide emergency shelter and basic necessities, our staff and volunteers also provide individuals staying at the shelter with additional support services to work toward obtaining self-sufficiency and assisting these individuals in getting back on their feet.

### **Remaining Resilient**

Homeless services across the United States have undergone rapid and drastic changes as a result of COVID-19. Beginning in March of this year, the Men's Shelter took a lead role in adjusting to the new way of executing homeless services in Cleveland in the midst of the global pandemic. By collaborating with Cuyahoga County, multiple service providers in the area, local hotels, foundations, and health care providers, the Men's Shelter was able to make life-saving changes for residents. These vital changes included cutting the Shelter census down by 65% by moving residents to hotel hubs, and testing shelter residents on a weekly basis. LMM has also safely provided breakfast, lunch and dinner every day through our Central Kitchen, and served 600 unduplicated people in local hotels.

### **Breaking New Ground**

LMM's Breaking New Ground affordable housing initiative is creating an innovative model for ending family homelessness in Cleveland by purchasing and renovating homes in the St. Clair Superior neighborhood. Families exiting homelessness will be

eligible for the new housing program, with rental fees capped at 30% of household income and connections to supportive services to ensure family stability. Demolition began late last year on the first home on Bonna Avenue in partnership with the Cleveland Browns. The forum featured panelists Judge Ronald Adrine, Cleveland Municipal Court (retired); Jennifer Lumpkin, Civic Engagement Strategy Manager with ClevelandVotes; Lana Mendis, LMM Employment Specialist and Chopping for Change alumni; Robin Turner, Ohio Organizing Collaborative; Joe Gaston, Board Member, North East Ohio Coalition for the Homeless; and was moderated by Margie Glick, LMM's Director of Advocacy.

The conversation focused on the importance of voting, myths surrounding returning citizens and voting rights, and how through advocacy, individuals can hold elected officials accountable after the election. This audience consisted of restored citizens, and the organizations, faith partners and community members who support their return to active civic engagement.

### **Extend the Impact of Your Gift this Season**



#### Maximize Your Giving This Year

At LMM, we are grateful for every contribution. We know that your gifts, large or small, come from your hearts.

If you've ever wondered what else you could do to ensure the work of LMM continues, we have a few ideas for you. Here are some simple ways you can maximize your financial contributions right now, and even beyond your lifetime.



### **Donate Appreciated Stock**

If you have held any stock for more than a year, the worth of your portfolio has probably increased. When you donate the stock itself, your gift is worth 20% more

than if you sold stock and made a cash donation from the proceeds. By donating stock directly to LMM, you will avoid the 20% capital gains tax. You can deduct full fair market value of your stock donation up to the limit allowed by the IRS. This gives you the financial benefit of avoiding capital gains and receiving a tax deduction. Contact your broker for more information.



### **An IRA Rollover**

If you are at least 70½ years old, you can transfer up to \$100,000 directly from your IRA to LMM. Couples over 70½ years old can each transfer up to \$100,000. Aside

from providing LMM with a much-needed gift, you can benefit as well. For example, you can count the amount of your rollover toward your required minimum distribution for the year, tax free. You might also avoid taxation at a higher income bracket. The charitable IRA Rollover must be a direct transfer from the financial institution that holds your IRA to LMM. If you'd like to make an IRA Rollover gift to LMM, talk to you IRA manager or financial advisor.



### Leave a Legacy Gift

Most estate gifts to charities come from everyday people who leave a precious legacy behind in their will. For those of you who would like to extend your philanthropic reach beyond your earthly life, we would be honored

to welcome you to the LMM Legacy Society. Of course, it's not easy to think about our own passing from this earth. However, one easy way to make a long-lasting positive impact on the lives of people who are oppressed, forgotten and hurting is through a simple bequest in your will. You do not have to be a person of great wealth to do this. While some people do have more complex estate plans, a simple bequest is just that—simple.

If your will is already drawn up, all you have to do is contact your attorney and talk to them about indicating an additional gift in your will.

### Bringing 3D-Printed Housing to Northeast Ohio

Affordable housing shortages in the US are directly linked to homelessness and housing instability. LMM's proposed

3D-printed housing solution bridges environmental and socioeconomic gaps by leveraging private market trends and technology. Working with 3D-printing company, SQ4D, and supported by an expert team, LMM is currently exploring a mixed-income, carbon-negative 3D-printed housing initiative in Cleveland. 3D-printed housing is faster, cheaper to build and maintain, stronger, and less wasteful to produce and operate than traditional homes. If funded, the project has the potential to revolutionize the housing and construction sectors by making affordable and sustainable housing universally accessible. Stay tuned as we continue to assess this exciting opportunity!

# Guardianship Means Friendship at LMM

October is Guardianship Awareness Month, a time to highlight the important work of guardians who give their all to make the lives of those in need better.

LMM's Guardianship Services program operates in Cuyahoga and Lorain counties. The program provides legal guardians to indigent adults who cannot care for themselves and have often encountered abuse or exploitation. Our guardians serve as concerned, caring advocates and surrogate decision-makers. Guardians look after the emotional, social, financial and physical well-being of these vulnerable adults and seek the least restrictive living environment possible. We're grateful for the lifechanging work that our guardians do every day.

Tom Stevens is one of LMM's longtime guardians. He just hit the 17-year mark as a volunteer!


"I worked for the Cuyahoga County Board of Developmental Disabilities for 30 years before retiring in 2017," says Tom. "I was bothered by seeing people who had no guardian or advocate, or had an ineffective guardian. I thought I could make a difference in someone's life by becoming involved."

At the present time, Tom is a guardian for one ward, named Susan. She is the third ward he has been paired with over the years, with the previous two ladies having passed away. While it's hard to see his wards pass, he takes comfort in knowing they were cared for and he could make a difference in their quality of life while they were still here.

Tom says even though he is the volunteer providing the service, he gets a sense of belonging out of the experience, as well. He has even developed friendships with some of the other residents at his ward's nursing home. "One of my previous wards had a co-resident of Middle Eastern descent, like me. She suffered from dementia, and really didn't speak anymore, and never showed any emotion. One day, I decided to make some kibbeh, which is a Middle Eastern meat dish, and I took some to her to see if I could get a positive reaction from her. After she ate it, I became very animated, but the expression on her face combined with so. I've had better!' I guess I was glad to get a reaction out of her- even a negative one!"

Since COVID-19 began, visitations have changed, and he says it was hard having to limit visits to Facetime for so long. Creativity came in handy. "In May, the nursing home organized a car parade, in which I participated," explains Tom. "I painted a big sign and was able to display it out of my sunroof. I even got to stop for a minute or two to speak with Susan!"

Tom is looking forward to getting back to regular visits soon, and he longs for them to be the way they once were not so long ago. "I always try to make the life of my ward more comfortable, and more happy and enjoyable. I've always been honest with Susan and kept my word. I really miss the visits, and once per month, I would stop at McDonald's and get us breakfast sandwiches and coffee, and we would always have a nice visit chatting away. Whenever a resident or staff who didn't know me came into the dining room, she would proudly introduce me to them. The strong bond that we have is undeniable."

### **Strengthening Our Commitment to Social Justice**

More than 50 years ago, LMM was founded to serve and advocate for social justice in the City of Cleveland in the aftermath of the Hough Riots. We continue to serve this purpose by meeting the needs of vulnerable individuals in our community, many of whom are people of color.

In response to the growing social unrest taking place across America, LMM's Board of Directors and Senior Leadership Team have launched a Racial Justice Initiative to recommit our mission to social justice, racial equity and inclusion, and public advocacy for people who are oppressed, forgotten and hurting. We are deeply disturbed by the unwarranted use of excessive force by some members of law enforcement towards people in communities of color, the persistence of institutional racism, discriminatory practices in housing and the criminal justice system, and a lack of accountability and sense of urgency to amend these societal wrongs.

Recognizing that the change we hope to see in our community and our country should start from within, LMM's Board and Staff have taken several intentional steps to seek justice. Here are some of the ways that LMM is working to promote justice, equity and inclusion within our organization, and strengthen our public witness of the same.

#### Expressing our Support of Social Justice & Racial Equity
